Testimony for reinstatement of funding for Centers for Independent Living

#### Melanie:

Chairman Romanchuk, Ranking Member West and Members of the Finance Subcommittee:

My name is Melanie Hogan. I am the Executive Director of Linking Employment Abilities, and Potential called LEAP, a Center for Independent Living in Cleveland, where I have worked for 25 years.

While disability costs in Ohio's healthcare expenditures are over \$19 billion a year (as reported by the CDC), Ohio's investment in the Centers for Independent Living, to provide supportive and preventative services, has been flatlined, at \$252,000 since the year 2000. As described in the document in your packet, Ohio's support of the CILs is the lowest, by far, in all of our region.



Centers support the work of The Department of Developmental Disabilities, The Department of Medicaid, the Department of Aging, Opportunities for Ohioans with Disabilities and integrated health entities, which result in positive home and community-based outcomes for individuals with disabilities. This in turn produces significant cost-savings for our state.

We respectfully request that the CIL line item (415-520) for the Centers for Independent Living be reinstated. Currently the GRF dollars allocated to Independent Living are used to draw down federal match and they go to the Statewide Independent Living Council. These funds leverage \$3.69 for every state dollar. Other GRF dollars draw down the Federal Part B funds for the Centers at a 9:1 match. Beyond those two streams there are no other GRF dollars supporting Centers for Independent Living.

Reinstating and funding our line item with 1.8 million for the biennium will improve the Centers' ability to deliver an increased level of independent living services to under-served and unserved persons with disabilities in a time of increased need, and to expand the availability of independent living services to more Ohioans throughout our existing service area.

Linking Employment, Abilities and Potential

#### Chairman Romanchuk:

You had testified I believe, that \$3.69 savings for every dollar of GRF and I think, Mr. Ballard testified a \$40,000 saving for those moved out of institutions. Do you have an estimate of the total savings for the 19 independent living centers that may have generated based upon those numbers?

#### Melanie Hogan:

We have numbers based upon the number of transitions, not necessarily in all of the impact of the diversion work that we have. The amount that we predict that we've saved as result of the transitions that all of the centers have done has been over 101 million dollars.
